In case, if the minimum requirement is met as per rationalisation norms, only the senior most teacher/s shall be relieved.

The Mandal Educational Officers/Headmasters concerned are requested to relieve the Secondary Grade Teachers and its equivalent cadres who are transferred with instructions to report at their new stations subject to fulfilment of minimum requirement is met as per rationalisation norms. Further instructed to intimate the date of relieving and joining of the teachers promptly to the undersigned.

The teachers shall abide the terms and conditions as stipulated by the Government and are liable for any action deemed fit for violation of orders if any.

The Mandal Educational Officers/Headmasters/ School Complex Headmasters concerned are requested to take necessary entries in the Service Register of the individual regarding the Date of Relieving/Date of joining and availment of Special Category/Preferential Category if utilised under proper attestation.

These orders are issued subject to outcome of the final orders in WP No. 3962/2023 and batch cases pending before the Hon' ble High Court of Telangana.
