

ORDER:

Government have issued guidelines vide G.O.Ms.No.317, G.A (SPF) Dept., Dated: 06.12.2021 to apply for change of local cadres and subject to need administrative needs and availability of vacancies and as far as practicable, spouse will be accommodated in local cadre, After allotment of the employees of the erstwhile local cadres to the new local cadre under P.O.2018. However, this exercise was not completed in respect of certain spouses allotted to different local cadres.

2. The G.A (SPF.II) Department has issued certain guidelines in the reference 2nd read above, to consider the request received on spouse Grounds as per norms stipulated therein.

3. In continuation to the 3rd read above, the Director of School Education, Hyderabad vide 4th read above have scrutinized some other requests of the applicants received on spouse grounds and forwarded to the list of 136 applicants to the Government for issue of necessary orders in the matter.

4. In pursuance of the orders issued in the reference 2nd read above and in the circumstances reported in the reference 4th read above, Government after careful examination of the matter, hereby accords permission to the DSE, Hyderabad to consider the applications of (136) employees for change of local cadre on spouse grounds, as per rules in vogue in clear vacancies available in the districts as annexed to this G.O.

5. The Director of School Education, Hyderabad shall take further necessary action in the matter, accordingly.
